I hereby declare under penalty of perjury, that I have reviewed the information included in this form, its attachments, and accompanying documents and the same is true, correct, and complete. I am aware that Article 269 of Act No. 146-2012, as amended, known as the "Puerto Rico Penal Code," provides that: "every person who under oath or affirmation, testifies, declares, deposes, or certifies truly before any competent court, body, official, or person, and states as true any material or important fact which such person knows to be false, or who categorically states a material or important fact without being certain that it is true, shall be punished by imprisonment for a fixed period of three (3) years. If the convicted person is a juridical person, such person shall be punished by a fine of up to ten thousand dollars (\$10,000).
