I hereby declare under penalty of perjury, that I have reviewed the information included in this form, its attachments, and accompanying documents and the same is true, correct, and complete. I am aware that Article 269 of Act No. 146-2012, as amended, known as the "Puerto Rico Penal Code," provides that: "every person who under oath or affirmation, testifies, declares, deposes, or certifies truly before any competent court, body, official, or person, and states as true any material or important fact which such person knows to be false, or who categorically states a material or important fact without being certain that it is true, shall be punished by imprisonment for a fixed period of three (3) years. If the convicted person is a juridical person, such person shall be punished by a fine of up to ten thousand dollars (\$10,000). Moreover, under the circumstances set forth in the previous paragraph, any person who offers two or more conflicting testimonies, declarations, depositions, or certifications shall be guilty of perjury. In this case, it shall not be necessary to establish the truth or falsehood of the stated facts. Regarding the information provided pursuant to subsection 5(f) of Administrative Order 2021-03, those facts of which I cannot have personal knowledge of for being information provided by a third party, I declare that I have used the Donor Query System in the web portal of the Office of the Election Comptroller to verify the accuracy of the information thus received, and for such purposes, I hereby declare that the information provided in this form is consistent and compatible with the information contained in the aforementioned System.

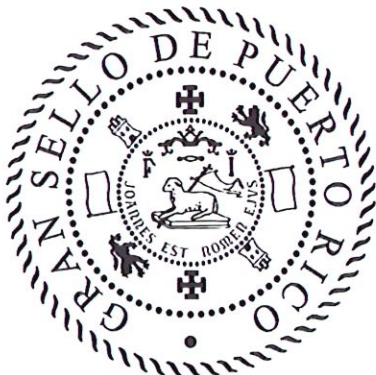
